

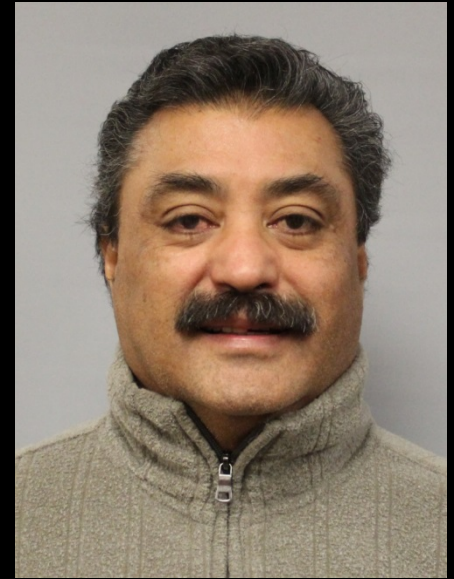
Minutes of the Weekly Provider Luncheon Meeting

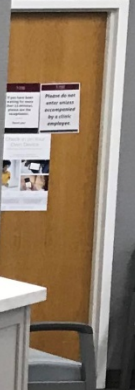
